

Board of Zoning Appeals – Alternate - The Board of Zoning Appeals consists of five members recommended by the Board of Supervisors for appointment by the Circuit Court to serve for a 5-year term. The Board meets to hear and decide appeals of decisions rendered by zoning administrators, interpret unclear provisions in the zoning ordinance and decide on applications by landowners to permit buildings or land uses which vary from the zoning regulations. Members must be residents of Greene County and qualified by knowledge and experience to make objective, fact-based decisions guided by zoning law. Professional Board of Zoning Appeals training is provided. Economic Development Authority – The Economic Development Authority has a board of seven directors appointed for four-year terms by the Greene County Board of Supervisors. The purpose of the EDA is to promote business development in Greene County consistent with the Comprehensive Plan, the direction of the Board of Supervisors and the intent of the legislation of the Commonwealth of Virginia. The EDA and the Director of Economic Development and Tourism work together to reach the County's economic development goals. The EDA Board meets the third Tuesday in January, March, May, July, September at 6:30 p.m. at the Stanardsville Town Hall located at 19 Celt Road, Stanardsville, VA. Rivanna River Basin Commission – The RRBC provides guidance for the stewardship of water and natural resources of the Rivanna River Basin and promotes activities by local, state, and federal governments, and by individuals, that foster resource stewardship for the environmental and economic health of the Basin. The RRBC was formed in 2007, as a result of enabling legislation passed by the General Assembly in 2004. Participating jurisdictions include Albemarle County, Fluvanna

County, Greene County, and the City of Charlottesville. The Commission is comprised of two elected officials from each of the participating jurisdictions, one citizen appointee from each of the jurisdictions, and one representative each from the Culpeper and Thomas Jefferson Soil and Water Conservation Districts.
