Coaches Code of Conduct

As a volunteer coach in any Greene County Parks & Recreation Department athletic program, I will pledge as follows:

I will provide a sports environment for my team that is free of drugs, tobacco and alcohol, and I will refrain from their use at all youth sports events.

I will place the emotional and physical well-being of my players ahead of a personal desire to win.

I will use no foul language of any form during any sporting events.

I will treat each player as an individual, remembering the large range of emotional and physical development for the same age group.

I will do my best to provide a safe playing situation for my players.

I will promise to review and practice basic first aid principles needed to treat injuries of my players.

I will do my best to organize practices that are fun and challenging for all of my players.

I will lead by example in demonstrating fair play and sportsmanship to all my players and players of opposing teams.

I will be knowledgeable in the rules of each sport that I coach and I will teach these rules to my players.

I will use coaching techniques appropriate for all of the skills that I teach.

I will remember that I am a YOUTH sports coach, and that the game is for children NOT adults.

I will follow the rules and regulations which may be applicable to specific athletic programs which I am coaching and the rules and regulations for the building, field, or gym where I am coaching.
